Key Findings and Lessons Learned:

This opens the conversation on how standardized testing wields great power in setting & establishing what is valued in a profession. Yousef is motivated to make anti-racism a required part of the curriculum for health care professionals - if it's on the exam, programs will teach to it. Tapping into musical theater experience and learning from fellowship's improv and executive presence sessions- he sought a compelling way to share his story.

Yousef wrote an original script in the 1st person to narrate his journey into a compelling short film to help influence other specialties' Boards as his CHIP presentation in April 2022. He collaborated with cofellow Dr Manisha Sharma for the design, timeline and production. Two finalist film-makers were interviewed and one selected based on experience, budget and timeline.

'Q' is the lead producer, editor and animator for the film. She has two collaborators for sound design and production. There will be an accompanying academic article on the journey of the Exam Writing Taskforce to put together these 20 questions to be submitted later this spring

Next Steps:

A communications and marketing strategy of the short film will be put together after production to reach leaders in the health professions to inspire specialty Boards and stakeholders in medical education to augment curriculum to include racism and the social determinants of health as a core component.

Project Description (include objectives, results, solutions): I wanted to share an emerging best practice of ACEs Screening and Trauma Informed Care with the three family medicine clinics at Santa Rosa Community Health. I believed I should do this to disrupt toxic stress physiology, creating better health outcomes for my patients as well as to create culture change of healing in my organization. The goal of the project was to train all staff at Santa Rosa Community Health on Trauma Informed Care and ACEs screening and to begin universal ACEs screening by 2021.

Key Findings and Lessons Learned

- I started with a Pilot at one of the three Family Practice Clinical Sites
- My CHIP aligned with state wide ACEs Aware Initiative and Center for Care Innovations Collaborative
- Lobtained \$200,00 in grants to support my CHIP and am now creating Supplemental Training for ACEs Aware and joined California Learning and Quality Improvement Collaborative
- I have trained 65 staff members and all of the 94 medical and mental health clinicians have been trained as well-
- Our community traumas (COVID, wildfires) helped us become more trauma informed as an organization.

Next Steps:

- Complete remaining training incorporating new curriculum guidelines from ACEs Aware.
 - Collaborate with Redwood Community Health Coalition on the region wide spread.
- Continue to advise ACEs Aware on State wide implementation.
- Train All Staff, not just clinicians.
- Involve the multi-disciplinary team in planning.
